# Checklist: Information You Should Gather After A Car Accident

We hope you never need to use the information contained in this guide. However, having this checklist handy can make all the difference in your personal injury case.

This printable guide has space to write down the information you need to gather after a car accident. Titan Law strongly advises you and any other drivers on your insurance policy to have a physical copy in all vehicle glove compartments for easy access.

Before you start documenting important information, though, there are some actions you should take immediately after the wreck.

- 1 Call 911.** In Florida, drivers must report auto accidents if they result in property damage, injuries, or death. You should also call 911 if the other driver leaves the scene of the accident. Even if you are initially unsure whether the accident caused injuries, having the police respond will ensure you have an official report.
- 2 Move your car out of traffic, if possible.** Florida law requires drivers to move vehicles out of the roadway after minor accidents. Make sure you can move and exit your vehicle safely before doing so.
- 3 Be careful about what you say.** Besides getting information from the other driver and speaking with the responding officer, you should refrain from saying anything. Your eventual insurance claim may be weakened if you say things like, “I’m sorry,” or “I didn’t see you.”

Again, we advise **PRINTING A COPY OF THIS GUIDE AND STORING A COPY IN YOUR GLOVE COMPARTMENT.** Having this checklist on hand can make a difficult and stressful situation a little bit easier.
